New California is a new state in development exercising its Constitutional Right to form from the State of California. The process to form New California is authorized and codified in Article IV Sections 3 & 4 of the United States Constitution.

Statement of Intent

The Citizens of New California have decided to remedy the abuse of power by the government of California by exercising their right to form a new state provided in United States Constitution Article IV Sections 3 and Section 4.

"We are determined to live under a State Government in the United States of America and under the Constitution of the United States."

New California Declaration of Independence of January 15, 2018 states:

Preamble of the New California State Constitution states:

First Amendment of the United States Constitution states:

"Congress shall make no law respecting an establishment of religion, or prohibiting the free exercise thereof; or abridging the freedom of speech, or of the press; or the right of the people peaceably to assemble, and to petition the government for a redress of grievances."

Declaration of Grievance Statement of Facts

United States Constitution Article IV Section 4

"The United States shall guarantee to every state in this union a republican form of government, and shall protect each of them against invasion; and on application of the legislature, or of the executive (when the legislature cannot be convened) against domestic violence."

CALIFORNIA STATE CONSTITUTION

ARTICLE I DECLARATION OF RIGHTS [SECTION 1 - SEC. 32]

(Article 1 adopted 1879.) SECTION 1.

All people are by nature free and independent and have inalienable rights. Among these are enjoying and defending life and liberty, acquiring, possessing, and protecting property, and pursuing and obtaining safety, happiness, and privacy.

The economic wreckage of such a punitive tax would plunge the global economy into a permanent depression—and that's assuming politicians could enact such huge tax increases over the will of their voters.

The violent protests in France were fueled by intense frustration felt by a middle class that sees itself squeezed. They don't earn enough to be part of the elite unconcerned with fuel taxes, but they work hard enough that they don't qualify for the generous welfare benefits handed out to the nation's poor and to newly arrived immigrants from Africa and the Middle East".

The oppression felt in all aspects of California life today are the result of the Agenda 21 and 2030 Agendas. While we in New California State have a U.S. Constitution to provide guidance to a new state the French do not.
